Article III. Board of Directors

3. Election and Tenure

Each director named in the Articles of Incorporation shall hold office until the first annual meeting of membership and until his successor is elected and qualified, or until his earlier resignation, removal from office, or death. At the first annual meeting of the membership and at each annual meeting thereafter, directors shall be elected and each shall hold office until the next annual meeting of membership and until his successor is elected and qualified, or until resignation, removal from office, or death. In such elections, the persons having a plurality of votes shall be elected.

Ugly Angel Dinner Redux

The reunion dinner plan is etched in stone. We are booked into the Silver Peak Restaurant and Brewery for 1900 on Friday 9 July. The SPR&B is located at 124 Wonder Street, Reno, NV 89502, which is east of Virginia Street between Wells Avenue and Holcomb Street. Your Cabbie or GPS will know the way.

Dinner will be on the restaurant's deck. Whether we have it to ourselves or not depends on our turnout. If we can muster a hundred Angels, we own the deck! Anything less and we have to share, so sign up early.

In the interest of keeping your cost down, the BOD has decided to go with a buffet that will cost \$28 per person. The price, if you're getting anxious, includes the gratuity and taxes. Not too shabby for what's included. The menu we have selected follows:

Wine by the bottle will be available for sale during the dinner. The Silver Peak brews and serves their own craft beer, and generally has a selection of ten on tap. A 16oz is \$4.00 and a 22 oz \$5.00. Well drinks are \$4.74 and call drinks range from \$5.00 to \$5.75.

Since I'm leaving home nearly two weeks before the reunion starts to do a little fishing, **I need your dinner check no-later-than 15 June.** That, by the way, is a no shit date – no check, no din.

Every once in a while I get a letter that cries out to be shared because it touches us all. One such follows:

Dear Tom,

Though we've never met, I would like to thank you for your thoughtful e-mails informing me of important events in Popasmoke and Marine Aviation. I was a Corpsman who flew with the Angels and other MAG-36 squadrons between '67 and '68. My respect and affection for Marine aviators and ground crews remains eternal. I had the pleasure of meeting Top Houston and Billy Ray McNair during a brief visit to Cavanaugh last spring. For an old squid like me, who has purposefully avoided wartime organizations, meeting these two humble brothers was powerful both emotionally and personally. Along with yourself, I also owe a special debt to Ben Cascio, who has kind enough to inform me of the passing of my late brother Doc Jones.

It was my intension to attend this year's Reno reunion. Unfortunately my Tet acquired gunshot wound required surgery a month ago, and the recovery/rehab is progressing more slowly than anticipated, and I will not be well enough to travel. This development is an enormous letdown, particularly missing the opportunity to visit the few friends I've made since joining Popasmoke. I don't know how many more opportunities I'll have. I was, for example, hoping to meet the squadrons' various historians, and I'd very much hoped to arrange a ride in the flying 34's in Oklahoma.

Please do me the favor of extending my regards to everyone in Reno come July. It sounds as though you've arranged a fitting party in one of America's great destinations. Congratulations!

Thank you again Tom for all your hard work on behalf of brothers like myself. You are a hero times two.
